Fire Recue Preventive Measures to be Followed in the School

1. All the fire extinguishers fixed in the Schools must be maintained, with periodical checking, and should be ready always for its use.
2. Provide employees with prepare training in fire, prevention and protection. All employees must be trained to operate the fire extinguishers through demonstration and training by fire and Rescue department.
3. Ensure that, water is always available in the water tank/ water bodies.
4. When the concerned officers visit the school, fire certificate/ No objection certificate/ fire extinguishers record/ Demonstration records must be produced and regularly maintained.
5. Once in six month emergency exit demonstration must be conducted.
6. Emergency contact numbers must be displayed in the important placed in the campus.
7. The date and month of fire certificate/ No objection certificate, must be followed and action must be taken to renew the same one in a year.
